- h) Participate to a project closure workshop.

The Construction Company is expected to cooperate and coordinate closely with a Consulting Company, which is expected to review and approve all the submitted technical documents and to inspect the construction works.

The River Basin and Green Area Development and Administration Agency (RBGADA) now invites eligible construction companies to indicate their interest in providing the services. Interested companies must provide full background information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Companies may associate to enhance their qualifications.

Qualifying Criteria will be:

- Each bidder should attach renew Trade Licenses;
- For local contractor grade one and for international equivalent as per the standard of their respective business registration countries.
- Any State, Central Government or Bank should not have declared companies ineligible/blacklisted;
- Each bidder shall have finalized at least three public sanitation projects of minimum one million Euro each in the last five years, with demonstrated experience in developing countries or east Africa contexts
- Each bidder shall have finalized at least two different landscape architecture projects in the last five years;
- Each bidder shall have successfully completed at least one wastewater management project in the last 5 years. Experience must include natural wastewater treatment facilities;
- Each bidder shall have successfully completed at least three environmental and social baseline reports in the last 5 years;
- Bidders should have a pool of qualified and experienced (more than 12 years)
 professionals, which include Team Leader, Sanitation Engineer, Civil Engineer,
 Environmental Quality Expert, Landscape Architects with professional
 experiences in developing country contexts;
- Average annual turnover of at least 15 million Euro in the last five years;
- The Company shall demonstrate to own and/or currently rent and/or have an ongoing lease agreement for (at least) the following equipment: excavators, loaders, dump trucks, pick-up vehicle, concrete mixers, and water trucks;
- Documentary Support for all the above, with copies of documents & letter of completion from customers for projects completed shall be enclosed in the EoI.
