#### **Procurement Reference Number:**

The Government of Ethiopia has received financing from the Government of Italy for a project entitled "Riverside development project in Addis Ababa". The Urban Beautification and Green Development Bureau acting as executing agency for the funds, intends improves the environmental health conditions of a stretch of the river Kebena and promote environmental tourism in the area through the construction of sanitation and beautification facilities.

Tasks to be undertaken by the Construction Company:

- a) Assess the current regulatory and administrative aspects related to water, sanitation and land management at City and National level;
- Collect and analyse data on water, sanitation, utilities, land management, urban structure, hydrogeological context, social and institutional context;
- c) Develop a feasibility study for the rehabilitation/construction of public sanitation infrastructures, wastewater management systems (including natural wastewater treatment), laundry facilities, river engineering infrastructures (including naturalistic engineering infrastructures), trekking paths, resting areas, parking sites;
- d) Develop detailed engineering design of all infrastructures;
- e) Develop detailed mobilization and implementation plan, environmental management plan, workers' health and safety management plan;
- f) Implement all expected construction works;
- g) Provide as built drawings, specifications, operating manuals;
- h) Participate to a project closure workshop.

The Construction Company is expected to cooperate and coordinate closely with a Consulting Company, which is expected to review and approve all the submitted technical documents and to inspect the construction works.

The Urban Beautification and Green Development Bureau now invites eligible construction companies to indicate their interest in providing the services. Interested companies must provide full background information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Companies may associate to enhance their qualifications.

### Qualifying Criteria will be:

- The bidders must submit valid and renewed trade license. Specifically for Ethiopian companies, the bidders must submit VAT registration certificate, Tax clearance certificate in accordance with ITB clause 4.6;
- Any State, Central Government or Bank should not have declared companies ineligible/blacklisted;
- Ethiopian companies participating as single bidders or in JV with international bidders must valid certificate of competence from the mandated body CATEGORY - 2 and above renewed for the year 2014 E.C (2021 G.C);
- Ethiopian companies participating as single bidders or in JV with international bidders must demonstrate to be registered within the Federal Procurement Agency of Ethiopia supplier list in accordance with ITB clause 4.7;
- Bidders must demonstrate core business and number of years in government and donor financed businesses, with specific experience in East African contexts.
- Bidders shall demonstrate experience in public sanitation projects (toilets construction, wastewater management — including natural wastewater management, landscape architecture, naturalistic engineering) in similar assignments.
- Technical and managerial organizational chart of the company, highlighting all technical sectors included in the company, key professional staff as well as quality management system.
- Documentary Support for all the above, with copies of documents & letter of completion from customers for projects completed shall be enclosed in the Eol.
- EOI must be delivered to the Bureau located in the address written below before the end of 30 consecutive calendar days starting from the first day of issuance of this bid announcement until 10.00 am.
- Bid will be opened on the same 30<sup>th</sup> closing day and at the address stated below at 2.30 pm.
   In case the 30<sup>th</sup> day falls in a non-working day, bid closing and bid opening will be transferred to the next working day. Late bidders will be automatically excluded from the tender.
- The Bureau reserves the right to cancel part or all bids and any items on the bid.

Only shortlisted Companies will be asked to provide Technical and Financial Proposals in accordance with the procedures set out in the updated World Bank's guidelines. Shortlisting will be carried out also considering performances of previous assignments with the Urban Beautification and Green Development Bureau (former River Basins and Green Area Development Agency – RBGADA).
