Financial Requirements

2. The average annual turnover of the candidate or tenderer must exceed the annualised maximum budget of the contract in the period 2019-2021

Professional Requirements

- 3. Registration in the Companies' Registry (to be attached) or equivalent professional or trade register in the country of establishment, for activities appropriate to those covered by the contract (if not required to register, the reasons must be given, indicating any other documentation that would entitle the tenderer to perform the contractual service) (Annex 2);
- 4. Any further necessary certifications, relating to the activities to be covered by the contract (Annex 2);

Technical requirements

5. At least 3 years' experience in the supply of vehicles to foreign Government institutions (Embassies, Development Agencies), International Organisations, NGOs and any other clients relevant to the contract (a brief description of the tenderer's experience, demonstrating such experience is required) - (Annex 2);

The administration reserves the right to hold a draw selection procedure at a public meeting, should the number of interested operators exceed ten, on a date to be announced at a later date. The draw will take place anonymously by means of the prior allocation of reserved correspondence numbers to the operators concerned.
